OLD BUSINESS

Chairman Battaglia explained to the Board that a "Special Meeting" was necessary to discuss the Snack Bar concession for 2019. The original plan was to only look to open the concession during the summer YAC program which would require soliciting proposals limited to the 6 weeks of camp. In light of new information, the Board may want to consider, as was done in the past, a more long term solution. If that is the case, waiting till the next regular scheduled meeting would delay the process by a month and any new prospective occupant would completely miss the spring season at Smith's Clove Park, which would decrease the value of the license.

Discussion Followed: Commissioner Calvano asked if the April 19 return date was too aggressive. Chairman Battaglia stated it was necessary to be able to get someone in here by May. Commissioner Conklin questioned why the winning bidder would be permitted to make payment to the Commission over several months instead of a lump payment when awarded. He was advised that the Board agreed to allow this in order to attract more bidders. Mancuso advised that he would advertise in the "Legal Notices" and the Business Opportunity sections of the Times Herald Record. Finally the Board discussed advertising with a minimum bid amount; it was decided upon \$3,000

On a motion by Adm. Chair Vaccaro seconded by Commissioner Calvano, to authorize the advertising, requesting proposals to run the snack bar concession for seasons 2019 and 2020 with an option for 2021 as presented and with a suggested minimum bid of \$3,000.
